# ECTP FACH – Focus Area Cultural Heritage General Assembly

## Background

In this moment, the FP7 is in its concluding phase, and many successful Cultural Heritage research projects have been developed, mostly within the Environment Theme, but also in other programmes (e.g. infrastructure, ICT). However, new challenges are still to be faced, such as resource and energy efficiency, SME's and industry involvement, innovation beyond research, combination of natural and cultural heritage, etc. The first phase to draft the coming Horizon 2020 has been undertaken by the EC, followed and "concretized" in a formal proposal by the end of 2011, and now under examination by EU Parliament and EU Council. The future of Cultural Heritage within this new initiative has to be analyzed, and some pro-active actions are needed to promote the existing and the historic built environment and the whole tangible cultural heritage in this scenario. In 2012, the ECTP has continued its activity. Besides, other initiatives inside and outside the ECTP, that might have some influence on the FACH role and progress, have been launched or became more important. In particular the Joint Programming Initiative (JPI) on Cultural Heritage preparing joint activities at wide European scale (also in relation with ERA-NET Plus topic call , the Public Private Partnerships (PPP), in particular the PPP "Energy Efficient Buildings" applied to cultural heritage, the new initiative "REFINE", mentioned as the most relevant ones.

In this changing scenario and approach in the end of FP7, this General Assembly meeting is organized with the following objectives:

- Overview of ECTP and FACH current status
- Overview and short analysis of Cultural Heritage projects funded within FP7 (updated EC brochure on "Survey and outcomes" of FP projects)
