Candidates are required to submit a 1,000-word report in the form of a literature review, in which they will identify a research gap that requires further exploration within the field of vegan tourism. The report should also define the theoretical framework that will be used. The report must be written in English and be based on contemporary international academic literature.

Required Qualifications: Candidates for the above topic must hold a Bachelor's degree and a Master's degree from a recognized university in at least one of the following scientific fields: Tourism/Hospitality Management, Sociology, Social sciences, or Psychology. Research Topic Title: Religious Tourism

These include concerns related to the authenticity of the religious tourism experience, the need to protect sacred sites from the potential negative impacts of tourism, and the delicate balance between tourism development and respect for religious traditions and practices.

Candidates are required to submit a 1,000-word report in the form of a literature review. In this report, they must identify a specific research gap within the field of religious tourism that warrants further investigation, and state clearly the study's aim and objectives. The report should clearly define the theoretical framework that will guide the study. The report must be written in English and should be based on contemporary and relevant international literature. It should demonstrate a strong academic foundation by drawing on current scholarly sources, with the aim of contributing to a deeper understanding and effective advancement of this vital sector.

Required Qualifications: Candidates for the above topic must hold a Bachelor's degree and a Master's degree from a recognized university in at least one of the following scientific fields: Tourism/Hospitality Management, Sociology, or Psychology. Research Topic Title: Wine Tourism and Climate Change

Description: Wine tourism is a rapidly expanding sector of tourism that combines culture, wine gastronomy, and experiential activities, attracting visitors with a special interest in wine and its place of origin. The development of wine tourism contributes to strengthening local economies, promoting wine-producing regions, and preserving their natural and cultural heritage.

However, the climate crisis is significantly transforming the context in which both the wine and tourism industries operate. Its effects influence wine production and quality, the geographical distribution of vineyards, and the overall conditions of tourist visitation and experience. These changing climatic conditions require wineries and tourism stakeholders to adopt adaptation strategies that integrate sustainability, innovation, and effective communication.

The proposed PhD thesis focuses on exploring the relationship between climate change, wine tourism, and wineries' adaptation strategies. Special emphasis is placed on understanding the perceptions, attitudes, and intentions of Mediterranean wine tourism communities and visitors toward the practices developed by wineries to address climatic challenges. The goal is to capture how these strategies influence visitor experience, satisfaction, and behaviour, contributing to the development of more sustainable and resilient models of wine tourism.

The PhD thesis combines theoretical and empirical research in the field of tourism, emphasizing the sustainable management of Mediterranean wine tourism destinations. It examines the perceptions and attitudes of wine tourism communities and visitors toward winery adaptation practices in response to climate change. The ultimate aim is to generate knowledge that supports the advancement of more sustainable and resilient forms of wine tourism.

This PhD programme offers a comprehensive and in-depth training framework that includes the teaching of empirical research methods, methodological tools, and advanced research skills. The nature and complexity of the topic require full dedication and active research engagement by the PhD candidate.
